On the evenings of **February 18 & 19**, **Father Paul CB Schenck** is available to speak on: **“Rights, Wrongs and Responsibilities: My Third Of a Century In Pro-Life Activism”**.

Father Schenck and his identical twin brother Rob, effectively shut down the abortion industry in Buffalo, New York with their unprecedented **PRO-LIFE ACTIVIST** efforts. So effective were these efforts, that they were sued by the abortionists in Buffalo. Father Schenck went to Federal Prison as a result. Their case went all the way to the Supreme Court and is one of the landmark cases in the history of our movement. Father Schenck founded **The National Pro-Life Center of Video of This Talk Available at [DefendLife.org](http://DefendLife.org)** which continues to do great educational work in the Judicial, Legislative, and Executive areas of our Federal Government. Presently, he is the **Respect Life Director** for the **Diocese of Harrisburg**. He is also responsible for Deaconate formation in this huge diocese. He and his wife Rebecca are the proud parents of 9 children, one in Heaven. Father Paul and his entire family are Converts to Catholicism.



On the evenings of **March 17 & 18**, **Father Peter Ryan, SJ** is available to speak on: **“The Church and Contemporary Culture on Sexual Morality & Abortion: Bridging the Great Divide”**. Father Ryan is a graduate of **Loyola College** where he later taught Theology, was the moderator of the **Student Pro-Life Group**, and hosted **DEFEND LIFE** lectures. Later, he taught at **Mount Saint Mary’s Seminary in Emmitsburg, Maryland** and the **Kenrick-Glennon Seminary in St. Louis, Missouri**.



Father Ryan, presently a missionary in the West African country of Togo, was the founder of **Seminarians for Life**. Father Peter Ryan is presently the **Executive Director for Doctrine at the United States Catholic Conference of Bishops**.

On the evenings of **April 14 & 15**, **Joan Andrews Bell** is available to speak on: **“My Years Rescuing Babies from Abortion”**. Joan Andrews is a true hero of the PRO-LIFE Movement. She grew up on a farm in Tennessee. **As a teenager, she began doing 1 person rescues at abortion mills!** She was arrested countless times. In 1985, she did a 1 person rescue at an abortion mill in Pensacola where she attempted to deactivate a suction machine. She was sentenced to serve 5 years in the worst of all of Florida’s women’s prisons.

In 1989, after her release, she spoke to a standing **audience at Loyola College** where she was introduced by **Archbishop John Rich**, **Bishop of Pensacola, Florida**.
