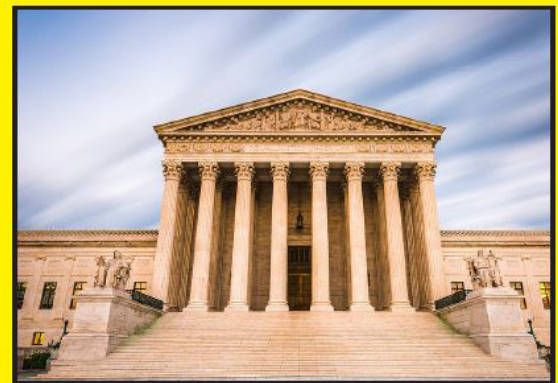
Spiritual Implications of the Dobbs Vote

When the Roe decision was handed down in 1973, various states' laws preventing abortion were effectively nullified. Abortion was, for the first time in the nation's history, permitted by judicial fiat. The United States, as an entire country, became guilty of massive blood-letting of innocent babies. We have suffered ever-increasing consequences since. We know that sin has the effect of darkening the intellect and weakening the will. We see that on a national scale. Wouldn't it be nice to see the United States actually influencing the world to Christian morals instead of degeneracy?

The Debbs ruling didn't happen overnight, just as the conditions leading to the Rose ruling 49.5 years ago didn't. Much pro-life work was done by dedicated Christians and pro-life people over the decades, many of whom passed on before they could see this day. They worked at pregnancy centers, stood in front of abortuaries, were arrested during rescues, worked for

legislative and electoral change. In 2020, Donald Trump was elected and he appointed three Supreme Court Justices, shifting the Court towards a conservative mindset that interpreted the Constitution in its original light.

When the Court's draft opinion was leaked, the minions of the demons (for that is what the pro-choice crowd is, even if they don't accept that) went berserk, vandalizing churches and pregnancy centers and threatening the Justices. An assassination attempt against Justice Kavanaugh was thwarted when the perpetrator turned himself in.

The Court released other opinions, unrelated to Dobbs, that indicated their collective mindset (probably to the chagrin of Breyer, Kagan, Sotomayor).

Legal Implications of the Dobbs Vote

The historic *Dobbs v Jackson* ruling that was announced on June 24, 2022 by the Supreme Court has implications that reach far beyond the Mississippi law on which the Court ruled. Both the pro-life community and the pro-abortion community understood the significance. The pro-abortion community, spurred on by the leak of the majority ruling, was so fearful of the implications (namely, loss of revenue and the general setback to progressive causes) that they launched a campaign of violence to intimidate the Justices into casting pro-

abortion votes. In the end, the three usual suspects (Breyer, Sotomayor, Kagan) did. Chief Justice Roberts, while voting to uphold the Mississippi law, declined to vote for the overturn of *Roe* and *Casey*.

Justice Alito wrote the majority opinion, found at the Supreme Court site www.supremecourt.gov/opinions/21pdf/19-1392_6j37.pdf I cut and paste two key paragraphs. “We hold that *Roe* and *Casey* must be overruled. The Constitution makes no reference to abortion, and no such right is implicitly protected by any constitutional provision, including the one on which the defenders of *Roe* and *Casey* now chiefly rely—the Due Process Clause of the Fourteenth Amendment. That provision has been held to guarantee some rights that are not mentioned in the Constitution, but any such right must be “deeply rooted in this

Nation’s history and tradition” and “implicit in the concept of ordered liberty.” *Washington v. Glucksberg*, 521 U. S. 702, 721 (1997) (internal quotation marks omitted). The right to abortion does not fall within this category. “

Further into the text of the opinion we read, “Instead of seriously pressing the argument that the abortion right itself has deep roots, supporters of *Roe* and *Casey* contend that the abortion right is an integral part of a broader entrenched right. *Roe* termed this a right to privacy, 410 U. S., at 154, and *Casey* described it as the freedom to make “intimate and personal choices” that are “central to personal dignity and autonomy,” 505 U. S., at 851. *Casey* elaborated: ‘At the heart of liberty is the right to define one’s own concept of existence, of meaning, of the universe, and of the mystery of human life.’ The Court did not claim that this broadly framed right is absolute, and no such claim would be plausible. While individuals are certainly free to think and to say what they wish about ‘existence,’ ‘meaning,’ the ‘universe,’ and ‘the mystery of human life,’ they are not always free to act in accordance with those thoughts. License to act on the basis of such beliefs may correspond to one of the many understandings of ‘liberty,’ but it is certainly not ‘ordered liberty.’ “

As I read those sentences, I can see the implications not only for abortion, but all other manners of aberrant behavior, once criminalized but now enshrined as “rights”, most notably the gay agenda and subsequent attacks on the very concepts of marriage and family. Also to be considered is the coordinated

push to legalize “assisted suicide”.

Towards the end of the court opinion, Alito writes, “But we cannot exceed the scope of our authority under the Constitution, and we cannot allow our decisions to be affected by any extraneous influences such as concern about the public’s reaction to our work.” That, of course, includes the pickets outside their homes and the assassination attempt against Justice Kavanaugh.

Justice Thomas wrote a concurring opinion for the express purpose

Justice Thomas wrote a concurring opinion for the express purpose of emphasizing that there is no abortion guarantee in the Due Process Clause

of emphasizing that there is no abortion guarantee in the Due Process Clause and in fact guarantees no substantive rights at all. Moreover, he states that “substantive due process is an oxymoron that lacks any basis in the Constitution”. Why? Because, as he quotes, “The notion that a constitutional provision that guarantees only ‘process’ before a person is deprived of life, liberty, or property could define the substance of those rights strains credulity for even the most casual user of words.” Under that doctrine, he states that first “The Court divines new rights in line with “its own, extraconstitutional value preferences” and nullifies state laws that do not align with

Some unpleasant truths about those COVID-19 vaccines

I am very thankful to God for having about 50 years of continuing education, work and teaching experiences in the fields of Diagnostic and Research Laboratory Technology, Microbiology, Immunology, and Molecular Biology. This enables me to recognize governments' continuing fraud and deception in their COVID-19 testing and vaccine policies, revealed in the Grand Jury Investigations in the Court of Public Opinion for Crimes Against Humanity.

These policies allow them to be in lockstep with the World Economic Forum's diabolical New World Order agenda.¹¹

Initially, like many, I was hoping for a "safe and effective" gene-based vaccine, even though the taxpayers-funded Pfizer, Moderna, J & J and AstraZeneca products were either tested or grown in abortion-derived fetal cell lines, have unprecedented very shortened clinical trials, and limited safety and efficacy data.

Honest physicians and scientists are alarmed about these vaccines, and have warned of the dangers if deployed in a rushed and indiscriminate mass vaccination.^{1,4,7,8}

However, soon my hope turned into disappointment and great concern when government, mainstream media, and medical and pharmacy boards started to misinform the public on alternative safe and effective early treatments like Ivermectin and Hydroxychloroquine.

They also censored, maligned, and suspended or fired esteemed doctors who prescribed them and pharmacists who filled them.

I was also alarmed at the mounting number of deaths and serious side effects that have been reported to CDC- VAERS (Vaccine Adverse Events Reporting System).

Shortly after the "vaccine" rollout and at 2 months, the reported deaths already exceeded the average yearly safety threshold of any previous drug/vaccine and all (>12) vaccines combined.^{1,2,4,5,7,8,10}

Thus, in early-mid 2021, several non-profit organizations listed below intensified their warnings through webinars and news reports regarding the dangers of the "vaccines," which remain experimental, still in Phase III clinical trial, and should not be given without informed consent, much less mandated.

All of which, along with infection prevention and early treatment protocols and lists of participating doctors and pharmacies nationwide, I promptly shared with family and friends, with the hope that they all take heed and stay away from these "dangerous shots."^{1,2,4,5,7,10}

I was therefore deeply saddened when my sister died from an aggressive cancer in May (7 months after diagnosis in November) and after being triple-vaccinated under the strict Canadian government mandates.

Her case, and several early-onset cancers and breakthrough cases in the fully vaccinated in my circle, seem to confirm the reports that the populace that are triple- and quadruple- vaccinated during the last 19 months since the vaccine rollout last year are experiencing more breakthroughs and are more susceptible to infections, neurological, autoimmune diseases and cancers than the unvaccinated.

Their poor pandemic response measures were to prevent an infection that is 99.95%-99.97% survivable with early treatment.

the judicially created guarantees.“ Second, “Second, substantive due process distorts other areas of constitutional law. For example, once this Court identifies a ‘fundamental’ right for one class of individuals, it invokes the Equal Protection Clause to demand exacting scrutiny of statutes that deny the right to others.”

In other words, it’s judicial tyranny. The left has always counted on that to impose their agendas on a populace that would otherwise reject them. Ironically, a third fault to “substantive due process” mentioned by Thomas is its effects, demonstrated by the *Dredd Scott* decision in which the Court ruled that Congress could not emancipate slaves brought into federal territories.

From that he concludes that the Court should “reconsider all of the Court’s substantive due process precedents, including *Griswold*, *Lawrence* and *Obergefell*. Recall that *Griswold* was the first case to insinuate a false notion of the “right to privacy” as it dealt with the distribution of contraception. The other two cases dealt with “gay marriage” and homosexual perversions. They all rely on bogus “rights” conjured out of thin air by judicial fiat known as “substantive due process”.

Justice Kavanaugh, in his own concurring opinion, agrees with Thomas. “This Court therefore does not possess the authority either to declare a constitutional right to abortion or to declare a constitutional prohibition of abortion.....In sum, the Constitution is neutral on the issue of abortion and allows the people and their elected representatives to address the issue through the democratic process. In my respectful view, the Court in *Roe* therefore

erred by taking sides on the issue of abortion.”

Regarding the doctrine of *stare decisis*, Kavanaugh says, “When precisely should the Court overrule an erroneous constitutional precedent? The history of *stare decisis* in this Court establishes that a constitutional precedent may be overruled only when (i) the prior decision is not just wrong, but is egregiously wrong, (ii) the prior decision has caused significant negative jurisprudential or real-world consequences, and (iii) overruling the prior decision would not unduly upset legitimate reliance interests.... Applying those factors, I agree with the Court today that *Roe* should be overruled. The Court in *Roe* erroneously assigned itself the authority to decide a critically important moral and policy issue that the Constitution does not grant this Court the authority to decide. As Justice Byron White succinctly explained, *Roe* was ‘an improvident and extravagant exercise of the power of judicial review’ because ‘nothing in the language or history of the Constitution’ supports a constitutional right to abortion.”

Of interest to us as both Catholics and American citizens is how and when the *Griswold*, *Obergefell* and *Lawrence* cases will be reviewed again, presumably in the context of future cases such as *Dobbs v Jackson Women’s Health Organization*. Not only does this ruling bring hope of restoring judicial sanity and restraint to our Court system and recognition of the importance of the legislative/election processes, but also of restoring national morality to some conformity with God’s laws.

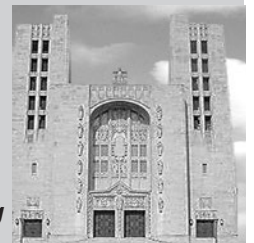
- In *New York State Rifle and Pistol Association Inc v Bruen*, the Court ruled that New York’s requirement to get special approval for concealed-carry permits was unconstitutional.
- In *West Virginia v EPA*, the Court ruled that the EPA has not the authority to regulate power plants
- The Court ruled that Maine could not exclude religious schools from the voucher program that it offers to parents in rural areas without public schools
- In a unanimous ruling, the Court ruled that Boston could not exclude Christian flags outside City Hall as it celebrated diversity

Thanks be to God, Roe is history! Thanks to the great opinion written by Justice Samuel Alito, thanks to President Donald Trump, who nominated the 3 justices who made the June 24 reversal possible, but especially to the late great **Nellie Gray**. Here are some recollections about Nellie from Larry Cirignano, Peter Shinn, and myself:



- In the summer of 1973, Nellie Gray introduced a resolution at the **National Right to Life Convention** calling for a March on Washington on January 22, 1974, commemorating the horrendous Supreme Court decision legalizing **abortion**. Amazingly, her resolution was **rejected!**

- Not to be dissuaded, Nellie founded the **March for Life** with the help of then **Archbishop Patrick O'Boyle** of Washington and others at her humble rowhouse just blocks from the Capitol.

- Nellie stepped down from her position working at a federal government agency and dedicated her full-time efforts to the March for Life, never taking **1 cent** in payment, and even sending back personal donations sent to her.

- All who worked with her also worked as **VOLUNTEERS**.

- Nellie said from the beginning that we needed a **Human Life Amendment** protecting every **pre-born** child from the moment of conception with **NO EXCEPTIONS** and **NO COMPROMISE!**

- Here are some of my personal recollections of Nellie:

- ◆ It was July 1976, the year Jimmy Carter, the former Democrat Governor of Georgia, was nominated for President. Carter claimed to be a **BORN-AGAIN CHRISTIAN**. Nellie amazingly arranged for a special March for Life in New York City the day before the Democratic Convention was to begin at Madison Square Garden. Somehow, Nellie was able to get a permit enabling us to march all the way from **Central Park** to **Madison Square Garden**.

- ◆ A busload of **PRO-LIFERS** left from Springfield, Virginia that Saturday to attend. I was able to make a huge banner on a 40-foot-long by 4-foot-high roll of cardboard. It simply said, **JIMMY CARTER, TO BE BORN AGAIN, ONE MUST FIRST BE BORN — STOP ABORTION!**

- ◆ When Nellie saw that banner, she insisted that our group lead the march, which we proudly did.

- ◆ Another recollection is when Nellie honored us by attending one of our **DEFEND LIFE** talks at Loyola College.

- ◆ Another recollection is from Nellie's Latin Tridentine Funeral Mass at Old Saint Mary's in Washington where she loved to attend Mass regularly. Nellie's remains were interred at a **cemetery** just east of the District. I was told that a good soul donated that cemetery lot.

Dee Becker, the late co-founder of the **March for Life** had a great idea! Nellie's earthly remains should be reinterred at the **Shrine of the Immaculate Conception** in Washington. Pray fervently that this happens soon. Pray also that the statue of **Our Lady of America**, as she appeared in Rome, Indiana in the 1950s, is warmly welcomed there soon and properly venerated. **May both events happen soon!**

First Post-Roe Face the Truth Tour

On July 29, 2022, the 22nd annual Face the Truth Tour, spearheaded by **Defend Life**, concluded. This tour was different in that it was the first Tour to happen after the repeal of the odious Roe v Wade decision. Many pro-life activists worked throughout the years to see its demise; many are seeing it now from their heavenly perspectives. However, they knew, as well as do we, that while Roe's end was a necessary facet in our pro-life mission, it is only a step to bring about protection for the unborn child.

These beliefs were echoed by many of the participants in the last two stops of the tour. Duffy and Rochelle Kane were the two directors of this year's tour. Rochelle commented that Church Militant lent their assistance to this tour, soliciting affiliates from all over the US to attend. They came from Washington state, New York, Massachusetts. She also pointed out that it was her seeing the pictures of the victims of abortion as a child that steered her towards the pro-life movement. When she saw that, she had asked her mother what is it. Her mother replied, "that is abortion. It is murder and it is wrong." She and Duffy in turn brought their children so that they can see the truth and can be inoculated against the pro-abortion brainwashing that they will receive in public schools.

Another lady, Kelly, has been at every Tour since its inception. She also participate in prayer efforts at shopping centers in Bel Air. Agatha came from Brooklyn NY to join us. She gave "thanks to God for giving (her) the strength, courage and wisdom to be here because we have to

protect the unborn". Our conversation was interrupted briefly by an angry motorist blaring her horn and giving us the "one-finger salute".

After our time in front of White Marsh was over, we went to a near-

by church where we had lunch. After lunch, we heard two talks. The first was from Emiliano Bell, son of Christopher and Joan Andrews Bell. Emiliano is from Mexico. He related how his story began when he was found in a trash can as an infant. He was born with several physical handicaps. He was put in an orphanage and was adopted by the Bells at the age of five years. They immediately introduced him to the pro-life movement. He participated in a rescue at the age of

nine and saved an unborn child from abortion. The father of the baby in question brought the mother for an abortion because they received news that the child was missing a limb. He told the father to “look at me, I’m happy”. Emiliano ended his talk by stating that this was his first tour with Defend Life and that he hopes to join subsequent ones. The second talk was given by Barry Sullivan. His talk will be covered in a separate article that will appear in the next issue.

After that, we headed to the final stop of the tour, on Route 40 in Catonsville by the Pike’s Park Plaza Shopping Center. We were in the middle meridian strip. It was drizzling much of the time, but still we stuck with it. Route 40 is heavily traveled during rush hour, so many motorists saw the truth of abortion. As we did at White Marsh, we received mostly positive feedback from motorists, with some fingers and cursing from pro-abortion folks. That is to be expected. When truth is brought to light, it will either be accepted or rejected; there is no middle ground.

As mentioned in the beginning of this article, this Face the Truth Tour is the first one to happen since Roe v Wade was struck down. Maryland’s laws, though, remain one of the most conducive to the murder of babies. If nothing else, abortions will increase in Maryland as abortion-minded women will come here from states that restrict or forbid abortions. We have much work ahead of us. These Face the Truth tours will remain a key tool towards informing Marylanders of the horrors of abortion, pricking the consciences of abortion supporters and even saving some children from being torn asunder by abortion

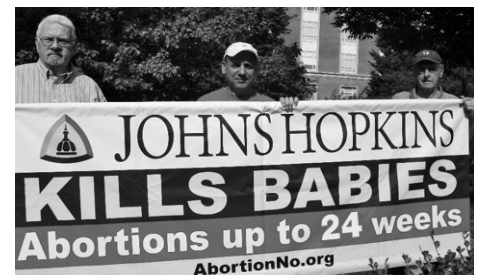

Raising a conservative daughter: not easy, but worth the effort

Young women today are bombarded with Leftist propaganda on a daily basis from Liberal media, academia and government.

How can a conservative parent fight back against this relentless onslaught to which her daughter is subjected?

Michelle Easton tells us how in *How to Raise a Conservative Daughter*.

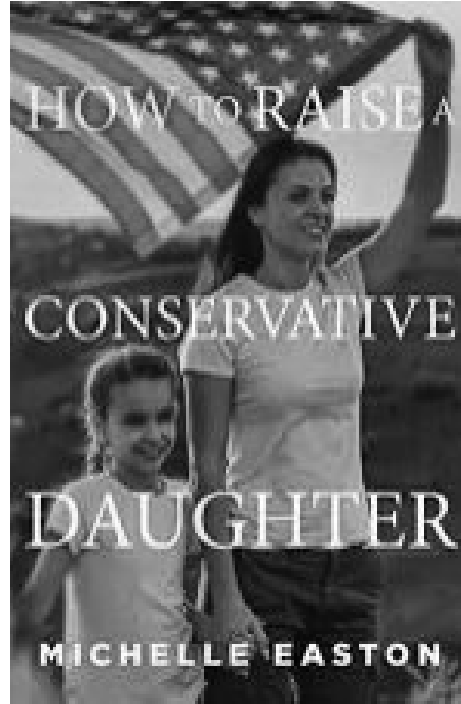
After working for 12 years in the U.S. Department of Education under Presidents Ronald Reagan and George H.W. Bush, writes Easton, “I realized there was a need for an organization that could mentor and support conservative girls and women.”

So in 1993, she founded the Clare Boothe Luce Center for Conservative Women

In the nearly three decades since, says Easton, thousands of Center alumnae have served on the frontlines, “promoting constitutional principles such as individual freedom, economic liberty, limited government, pro-life causes, and traditional values at the local, state and federal levels.”

The Center’s namesake, Clare Boothe Luce, pioneered in breaking the “glass ceiling” for women in leadership positions. Luce was editor of *Vanity Fair* magazine, a journalist on the frontlines in Europe and Asia during World War II, and the first female ambassador to a major nation (Italy). A wife and mother, she was a devout Catholic, a convert instructed in the faith by Bishop Fulton J. Sheen.

How to Raise a Conservative Daughter lays out the bedrock con-



servative principles that parents need to teach their daughters. It follows up with practical, “how-to” tips for imbuing her with these principles, whether she’s in grade school, a teenager, or in college.

On teaching economic principles, for example, Easton advises, “Every young child needs a piggy bank. They are an excellent tool for teaching kids about managing money.”

As she gets older, the lessons expand. “A 10-year-old can understand

the stock market,” Easton asserts; “let your girl pick a favorite stock and chart its progress.”

Along the way, she will learn the important concept of delayed gratification: that achieving what one desires takes time and hard work.

Another important concept for your daughter to grasp is the value of voluntary service to those in need—beginning with helping out members of her own family, expanding to help an elderly neighbor with her yard work, and then volunteering at a pregnancy center or an animal shelter.

Turning to college activism, Easton urges college women not to let Leftist radicals monopolize campus events. She suggests bringing a conservative speaker to her campus, organizing a group to attend the annual March for Life in Washington—or even, as a concrete way to help her feminine peers understand and value their Second Amendment rights, sponsoring a supervised trip to a gun range!

Finally, she points to outstanding conservative women, both past and present, who can act as inspirations and models, including British Prime Minister Margaret Thatcher, Equal Rights Amendment foe Phyllis Schlafly, Right to Life leader Dr. Mildred Fay Jefferson, Saint Teresa of Calcutta, U.S. Senate leader Marsha Blackburn, and Trump Senior Counselor Kelleyanne Conway.

Raising a conservative daughter in a hostile and often toxic culture is not easy, concludes Easton; “but nothing worth doing ever is.”

Pro-Abortion Tempter Tantrums in Wake of Dobbs Decision

We all recall that on May 2, a draft of the Supreme Court Dobbs ruling was “leaked” to the public. Immediately thereafter, various pro-abortion groups issued threats against the Supreme Court Justices and against pro-life-related establishments in general. Those establishments included churches and pro-life pregnancy centers. Those threats came so close on the heels of the leak that one can wonder if the pro-aborts knew that the leak would occur and were prepared for it.

Those threats were not idle chest-thumping and bombast. Nationwide we heard of churches and pregnancy centers being torched and vandalized, some beyond repair. This went on for weeks, with very few arrests to show for it. One group that called itself “Jane’s Revenge” took credit for much of the mayhem. Their use of the name “Jane” is patently dishonest, since “Jane Roe”, that is, Norma McCorvey converted to Catholicism and worked to overcome the ruling that bore her pseudonym.

The MD-DC-VA area bore its brunt of damage. On Saturday, May 14, the Alpha Pregnancy Center in Restertown MD was spray-painted by vandals associated with this “Jane’s Revenge” bunch. One of the messages read, “if abortions aren’t safe, neither are you”. On the same day in Frederick MD, Birthright of Frederick County was also the recipient of spray-paint graffiti. There is no indication that “Jane’s Revenge” took credit/blame for that one.

Several pro-abortion groups had promised a “summer of rage” and continued to target pregnancy centers and churches, particularly Catholic ones. On June 27 in Raleigh County in West Virginia, St Colman Catholic Church was burned to the ground as an act of

arson. It was listed on the National Register of Historic Places, with its original structure dating back to 1877. Three young men were charged with the arson, but no motive was divulged. On May 9, First Care Women’s Health in Manassas VA was spray-painted. Messages there included “fake clinic”, “abortion is a right”, “liars”.

On June 3, Capitol Hill Pregnancy Center in Washington DC was egged and spray-painted. “Jane’s Revenge” took credit/blame for this attack. Several years ago, I was part of a team that gave a sidewalk counselors’ training session there. It was clear that the place was geared to giving mothers spiritual and material help in order to care for their babies. So many pro-aborts snoot and snort about pro-life people not actually helping women, but now they tip their hands as they try to destroy the help that these new mothers could use.

On Sunday July 10, three churches in the Wildwood area of Bethesda MD, were vandalized with two of them undergoing arson. The three churches are St. Jane Frances de Chantal, Wildwood Baptist Church and North Bethesda United Methodist Church. The pastor of St Jane was alerted by the fire alarm system at 1:55 am. At St. Jane, arsonists set fire to the

inside of the church, destroying some pews. Fortunately, the flames did not touch the Tabernacle. \$50k worth of damage was done. The Methodist church also suffered arson damage. The Baptist church saw vandalism to its graveyard.

Other such attacks abounded throughout the country. The pro-aborts are being confronted with the idea that abortion is wrong and that God-fearing people are becoming a bit more galvanized against it. But the angst runs a bit deeper. Satan is now finding that his blood sacrifices are being curtailed. No longer can babies’ blood flow freely to him with the permission of the entire nation.
