



Feds Haul Away Pro-Life Activist In Front of His Frightened Children

Mark Houck is a pro-life activist in Pennsylvania and the founder/ president of the King's Men (see thekingsmen.org) He has been going to the Planned Parenthood mill known as the Elizabeth Blackwell Health Center in Philadelphia every Wednesday for four hours. On October 15, 2021, Houck was there with his young son and another prayer partner. A male deathscort, 72 years old, was there to rush women inside the mill so that their babies could be killed.

The deathscort took some time to harass the young Houck boy, and had been doing so for several weeks. Mark repeatedly told the deathscort to stop harassing his son. On the day of the incident, the boy walked down to a corner and the deathscort followed him. Houck pushed the deathscort away from his boy. At that, the deathscort pulled a dramatic flop scene then rushed into the mill. All this was recorded by Planned Parenthood's security cameras. Soon thereafter Houck got served with papers. The following winter, there were three different court dates with the District Court of Philadelphia. For the first one, the pro-life attorney couldn't be there.

The next date the pro-abort attorney didn't show. The judge then said if the pro-aborts didn't show for the third date, that he would throw the case out. The deathscort himself failed to show so the case was indeed thrown out.

That should have been the end of it, but the Department of Justice got involved. They were looking for a possible FACE violation. The video taken by Planned Parenthood showed that to be nonsensical. Prolife attorneys have a copy of said video. Moreover, the attached Google-Earth picture also makes a lie of the FACE charge. Any possible corner where the altercation took place is far enough from the mill entrance to render a FACE charge farcical on its face.

That didn't stop the ever-intrepid feds from borrowing tactics from the Nazi Gestapo and springing into action, as it were. On Friday, September 23, in the morning at 7:00 AM, 20-25 armed men barged into the Houck residence. They dragged Houck out in handcuffs in front of his wife and children, pointing their guns at the family as they did so. When Ryan-Marie asked the feds why they were there, they stated that they intended to arrest Mark. She asked for the warrant, and they told her they "were going to take him whether they had a warrant or not". Only when Ryan-Marie told them that constituted kidnapping at gunpoint did they produce a warrant.

They took him to the Federal

Detention Center at 6th and Market and arraigned him. They put him in handcuffs and leg shackles. They chained him to a table for four hours. Afterwards they let him out on his own recognizance.

If any of this sounds vaguely familiar, it should. Please refer to the May-June 2022 issue of the Defend Life newsletter (in the archive section of the web page). The article in question starts on page 4. Refresh your memories regarding the pro-life activists who engaged in a rescue at the DC mill of Cesare Santangelo on Oct 20, 2020. Armed agents of the Department of Justice burst into the homes of these prolifers, also in the wee hours of the morning. They too were let go after putting them through a harangue.

At the time of this writing, legal strategies are still being weighed and considered.

When Roe v Wade was finally relegated to the dung heap of history, it was obvious that Maryland, being the abortionists' mecca that it is, would draw more baby-slaughter cabals to take up abode within its borders. Concurrent with that development is the apparent disappearance of Leroy Carhart from Maryland, probably due to some health constraints. highlighted the two foundresses, Diane Horvath and Morgan Nuzzo. Horvath is a doctor while Nuzzo is a certified nurse midwife. Recall that on July 1, HB 937, the "Abortion Care Access Act" went into effect after Governor Hogan's veto was overridden. We had attempted to petition that bill to referendum and came close to doing so. Had the bishops allowed us access to church lobbies to collect signatures, we

Because of that bill, other medical professionals besides MDs can commit abortions: physicians' assistants, nurse practitioners and midwives are legally empowered to do so. That means both Horvath and Nuzzo can kill babies. Nuzzo sports quite the abortion-tainted resume: Director of Nursing at CARE abortuary in Bethesda (in other words, Leroy Carhart's mill), midwife at DuPont abortuary and an RN stint at the old DC Planned Parenthood location.

All in all, the RINO crowd in Maryland got their comeuppance that day. Solid conservative Dan Cox trounced Kelly Schultz to become the GOP nominee for Maryland governor. This was a direct rebuke to Larry Hogan. In standing against the mask mandates two years ago, Dan Cox was slated to speak at a rally in western Maryland. He was threatened with arrest by the Maryland State Troopers if that talk continued. The troopers are under Hogan's authority. He has also been solidly pro-life. Sadly, the same could not be said for his opponent, Kelly Schultz. While she started her career as pro-life, she back-peddled in anticipation of the gubernatorial race. This is one example of trying to please so many people that in the end, no one is pleased. More to the point, she threw unborn children under the bus. Did she think she would make political gains? If so, that strategy flopped, both politically and morally.

Michael Peroutka will go to the general election for the position of Attorney General. I know of no shortcoming on the part of his opponent Jim Shalleck and supported the latter when he ran for State's Attorney in Montgomery County. I believe Peroutka will bring a better sense of adherence to the Constitution in enforcing law.

Neil Parrott will face David Trone for the MD District 6 seat in the US House of Representatives. Bearing in mind that the district maps have been improved to remove at least some of the gerrymandering, Parrott has a real chance of winning the general election. Besides him and Andy Harris of District 1, I haven't a sense of the pro-life bona fides of the GOP candidates for the other US House seats. Suffice it to say that we need the GOP candidates to win, if for no other reason than

• He spoke numerous other times for us and other PRO-LIFE groups. One of the most memorable talks was at Holy Redeemer Church in Kensington, Maryland. It hadbeen arranged by long-time **PRO-LIFE** activist Larry Grayson. Larry found out that one of Bishop Joe's sisters was passing through while traveling back to her home in Naples, Florida. She came, hid off to the side, and surprised her brother with her presence.

• But here is **easily** my most memorable recollection of the 2 years Bishop Coffey spent with us. A dear, dear friend who was a convert herself, had a younger brother who was an **agnostic** and was dying of terminal cancer in a Baltimore hospital. She called Bishop Joe to see if he could possibly come and anoint her dying brother. Bishop Joe was in New Jersey on his way to visit friends. He immediately turned around, drove 2 hours through Delaware and then to Baltimore, anointed this man, and gave him conditional Baptism. Saving an immortal soul was much more important than his planned visit. He arrived at the hospital at 6pm that evening. The following morning at 6am the brother of my dear friend went to his Eternal Reward.

Even though Bishop Coffey has left the Baltimore area, let it be known that we are just loaning him temporarily to our great **PRO-LIFE** friends in Philadelphia. But seriously, for now he will be living at St. Colman's Church in Ardmore, Pennsylvania, near many of his siblings, nieces, nephews and lifelong friends. The Church is in such dire need of more fearless Bishops like Bishop Joseph Coffey.

(HCQ) and other treatments were vilified by Fauci because they posed a threat Dr. Fauci and Bill Gates \$48 billion COVID vaccine project. The only treatment allowed by Fauci was a failed Ebola drug, the highly toxic drug remdesivir, in which Gates had a large stake.
